2020 Frozen Semen Breeding Contract

This agreement confirms the nomination to the stallion Casco Bay (hereinafter referred to as the "Stallion") for the 2020 breeding season by the owner or lessee of the mare whose signature appears below (hereinafter referred to as the "Owner"). Owner hereby agrees to breed the mare _____ with the registration No. _____, registered in the following stud book _____, (referred to as the "Mare"). Breeding will be done by using the frozen semen supplied by Stallion AI Services (hereinafter referred to as "SAIS") through the North American Agent, Equine Stallion Services.

SAIS recommend Deep Uterine Insemination with frozen semen.

Terms and Conditions:

Stud Fee: US\$950 with 24h LFG

- Semen will be released one dose at a time, 1 dose of frozen semen to be made up of 6 straws and doses must not be split
- The stud fee does not include semen distribution costs
- All doses purchased under this contract **must** be used on the Mare nominated above.
- Doses being purchased for use in Embryo Transfer or any other advanced breeding programme are entitled to up to one pregnancy **only** per dose. If multiple pregnancies are achieved from the same flush or procedure, the full breeding fee of US\$950 will be charged for each additional pregnancy on confirmation of a heartbeat.
- ICSI is not permitted under the terms of this contract, but may be permitted upon request under different terms (please contact SAIS/Equine Stallion Services for more information).
- The Owner understands that this is a non-refundable, non-transferable stud fee and that no refund will be given under any circumstances.
- The transfer or re-sale of the straws covered by this agreement is not permitted.
- If the Owner wishes to sell any unused doses covered by this agreement, special permission from SAIS/ESS would be required. In that case a receipt of the sale, together with a copy of a separate Breeding Contract would need to be completed for every mare, in order for SAIS to issue a covering certificate.

Shipping and Handling:

- All distribution costs for the semen shall be the responsibility of the Mare Owner. Frozen semen will only be shipped by Equine Stallion Services upon receipt of payment.
- Equine Stallion Services/Equine Medical Center of Ocala (storage facility) shall ship frozen semen from the stallion in viable condition when it leaves the storage facility. Cryogenetics Ltd, SAIS, Equine Stallion Services, and the Equine Medical Center of Ocala hold no responsibility for shipping errors, misrouting, or mistreatment of the dry shipper by the shipping company, which might result in damages to the frozen semen.
- Cryogenetics Ltd, SAIS, Equine Stallion Services, and the Equine Medical Center of Ocala assume no responsibility for any loss or damage to the mare. The Owner shall assume all responsibility for the condition of the Mare and shall bear all risk of loss or damage to the Mare whether by death, disease, injury, infection, or otherwise.
- Empty straws must be returned to Equine Stallion Services.

SCHEDULE A

The Service. You will receive one dose of frozen semen per mare cycle. A dose is defined as the amount of semen required (by microscopic analysis at the time of collection) to get a mare in foal.

Ownership, Storage, and Use of Insemination Doses. At all times prior to insemination, the insemination doses shall remain the property of the SAIS. At all times after delivery and prior to insemination, the insemination doses must be stored under the supervision of the Veterinarian. All inseminations must be carried out by the Veterinarian, and may only be used to inseminate the Mare specified in this contract. The Purchaser is responsible for and will indemnify the Stallion Owner and Equine Stallion Services against all costs (including any costs of the Veterinarian) associated with the storage and use of the insemination doses.

Pregnancy Diagnosis. We recommend that all mares be examined by a veterinarian between 14 and 16 days after ovulation to determine pregnancy and spot possible twinning. Mares should then be checked again at 28-30 days to confirm a heartbeat. A final check should be made again at or before 60 days after ovulation to confirm the pregnancy. Please notify Equine Stallion Services of the results of each pregnancy examination.

The Contract. The Mare shall have the right of return of service to the Stallion only under the following circumstances:

1. If the Mare does not settle during the Present Breeding Season, she is eligible for return of service to the Stallion if the Purchaser submits a veterinarian's certificate to that effect.
2. If the Mare is examined in foal but aborts or reabsorbs the pregnancy during gestation, she is eligible for return if Equine Stallion Services receives a veterinary certificate of barrenness.
3. If the Mare subsequently produces a live foal that is unable to stand alone and nurse, and subsequently dies, a veterinary certificate must be provided to Equine Stallion Services.

In **ALL** cases, the required veterinary certificate will confirm that the Mare had been immunized for equine rhinopneumonitis (equine herpes type 1) during pregnancy and the date of such vaccinations.

Refunds. The stud fee will be returned only in the event that the stallion becomes unavailable before ANY insemination doses have been shipped to the Purchaser. Stud fees will not be returned if the mare fails to become pregnant.

Shipping

Frozen semen will only be shipped via FedEx Priority Overnight. Semen can be shipped out Monday through Thursday. Friday shipments will only be possible if you live in an area where FedEx offers Saturday delivery service. Please call Christine at 352-266-4669 to get your tracking number. Please **DO NOT** email urgent shipment requests, as we cannot guarantee that we will receive the email. Semen will be shipped from the storage facility, the Equine Medical Center of Ocala (address: 7107 W. Hwy. 326, Ocala, FL 34482).

To return the container, put an address label on the outside of the container and ship it back to the Equine Medical Center of Ocala via FedEx. Insure the container for \$900; this will protect you in the event the container is damaged en route. If you do not return the shipping container within 7 days, an additional fee of \$10 per day will be charged. If the container has not been returned within 14 days, the container deposit will be forfeited.

NOTICE: Please note that a FedEx number is required for the semen shipment. This policy was adopted because of the dramatic increase in declined credit card payments for FedEx shipments. When a credit card is declined by FedEx, the shipment is automatically billed to either Equine Stallion Services or the storage facility, EMCO. This means that the funds have to be tracked down, which incurs additional costs. Please call 1-800-GO-FEDEX to establish an account.
